a) Term:

This MOU shall be operational from the date of signing and will remain in effect for 5 years unless and until it is expressly terminated by either Party.

b) Obligation of parties

Parties shall contribute and fulfill the following obligations under the collaboration for the purpose of sharing expertise and mutually cooperating and exchanging relevant information for knowledge enhancement.

- 1.1. First party will provide an offline classroom for engaging the guest lectures within the college complex or online as per convenience, expertise from the Company can give the talks related to topics such as AI and ML, SAP, IoT etc. The remuneration for each lecture will be INR 3,000/- to INR 5,000/- per lecture.
- 1.2. First party shall identify suitable students for the value added courses and the Company can provide training to the students in the Summer/Winter break.
- 1.3. The Company can also provide guidance on projects and the first party will identify suitable student's /faculty members on the project and would ensure the completion of the project.

c) Duration
